Every multi-family complex in the City of Livermore is entitled to one free annual cleanup service per twelve (12) month period. Additional cleanup services may be scheduled but applicable charges apply. When your dates are confirmed and the location for your debris box determined, a completed version of the attached flyer will be provided electronically and you can distribute to your tenants. We will also provide an event poster for you to put up in a common area.
